Panel 1: A Look Behind the Curtain at the Transition of Presidential Administrations



MARK BARRON

Named a Law360 Energy MVP in 2016, Mark Barron enjoys a reputation as one of the most influential energy lawyers in the country. Mark has guided some of the country's largest producers of oil and gas through high-profile litigation and is a "go to" author for energy companies and trade associations developing technical comments responsive to regulatory initiatives. Mark routinely assists clients in the administrative rulemaking process, interacting with government decision makers, developing strategic policy initiatives and litigating disputes.

A prolific author and speaker on topics affecting energy producers, Mark has been featured or quoted in dozens of industry and mainstream media outlets on topics related to energy policy, hydraulic fracturing and commercial development on public lands. In 2015, Law 360 named Mark one of five national "Rising Stars" in Energy – a designation given to the best attorneys in America under 40 years of age.



LUKE JOHNSON

With an extensive background in legislative and regulatory strategy and planning, Luke Johnson provides sophisticated analysis of energy, natural resource and environmental issues. In working with industry clients, Luke utilizes his background as a trade association leader and government affairs consultant along with senior level experience with the Bureau of Land Management (BLM), the US Senate, and the US House Natural Resources Committee.

Luke is a former Deputy Director of Policy and Programs at the BLM within the Department of the Interior. He previously served as the Chief of Staff to the BLM Director and the Chief of Congressional and Legislative Affairs for the Bureau of Reclamation. During his tenure at BLM, Luke played an instrumental role in the implementation of numerous provisions of the Energy Policy Act of 2005, including oil and natural gas permit streamlining, the formulation of the oil shale rule, and other provisions relating

to permitting traditional and renewable forms of energy. Luke also provided executive management and oversight in the formulation and revision of numerous other BLM energy and public land policies, resource management plans, programmatic agreements between federal and state agencies, NEPA documents, rights of way and transmission corridor actions. He oversaw the agency's congressional and public affairs efforts and served as a witness representing the administration in testimony before the Senate Energy and Natural Resources Committee and the House Natural Resources Committee.

His experience also includes service as a Senior Policy Advisor to former Senator Robert F. Bennett (R-UT) where he handled comprehensive energy and environmental issues, including his role as a senior member of the Senate Appropriations Committee and Senate Energy and Natural Resources Committee. During his time in the Senate, Luke oversaw the successful passage of numerous public land bills, including a successful effort to authorize and appropriate funds for a multi-state endangered species recovery program. Prior to this work in the Senate, Luke served as Legislative Assistant for then Rep. James V. Hansen (R-UT) and as Professional Staff on the House Natural Resources Committee

where he was the primary staff member for 19 bills that became public law.

In addition to his tenure in government, Luke also recently served as Vice President of Policy and Government Affairs for the National Ocean Industries Association (NOIA), a national offshore energy trade association. There he led NOIA's efforts in developing and implementing the organization's policy and political affairs engagement strategies. In addition to maintaining key relationships at the federal, state and local levels, he also worked with like-minded organizations to build coalitions in support of the association's objectives. Luke was also previously a Founding Partner in EnergyNorthAmerica, LLC, a full service energy consulting firm.





DEWITT BURDEAUX

DeWitt Burdeaux is a Regulatory Subject Matter Expert (SME) for G2 Integrated Solutions, where he brings a 35-plus year career in the energy industry, including compliance oversight, training and research for state and federal agencies, as well as engineering, operations, and compliance consulting.

DeWitt most recently worked as a Regulatory Compliance Advisor for FlexSteel Pipeline Technologies, where he advised and assisted internal and external stakeholders in the applicability of federal and state pipeline safety regulations. He also represented the company on consensus standards committees and served as a liaison with state and federal agencies on regulatory activities having potential business impact.

DeWitt also worked 18 years for the US Department of Transportation's (DOT) Pipeline and Hazardous Materials Safety Administration (PHMSA), where he was responsible for

training federal, state, and industry personnel on pipeline safety compliance issues. He was instrumental in the implementation of PHMSA's Integrity Management for hazardous liquid pipelines regulations and was project manager for rulemaking regarding onshore natural gas gathering lines, hazardous liquids gathering lines, and low-stress liquids pipelines. While with PHMSA, DeWitt wrote the agency's Final Rule for regulating onshore natural gas gathering lines as well as the Notice of Proposed Rulemaking for crude oil gathering lines and other low stress lines transporting petroleum products. From its inception, he was a member of the team that performed all of the background research and development of the PHMSA Distribution Integrity Management (DIMP) rule. DeWitt frequently interacted with other federal agencies, including DOE, SBA, and OMB and worked closely with national industry trade associations like AGA, APGA, and GPA.

Prior to joining PHMSA, DeWitt was responsible for oversight of district compliance activities for a transmission and distribution company in Louisiana. After which he served as an enforcement officer for the Louisiana Department of Natural Resources' Pipeline Safety Enforcement Group for 6 years.

DeWitt is a three-time recipient of DOT's Superior Achievement Award and has also received the Administrator's Eagle Award and the Federal Excellence in Action Award. He has served as a consultant on a multitude of industry consensus standards as well as being a committee member of PHMSA's Pipeline and Informed Planning Alliance (PIPA) report.

GREGORY D. RUSSELL

Greg is a partner in the Columbus office and leads the firm's energy group, which is one of the largest and most experienced energy practices in the Midwest. For more than 20 years, he has been advising producers and pipeline operators in Ohio on business and regulatory matters, ranging from asset transactions, to unit operations and development, to leasehold and royalty disputes. Greg's practice frequently involves appearing before state and federal regulatory agencies, such as state oil and gas and public utility commissions as well as U.S. EPA, the U.S. Department of Transportation and the Federal Energy Regulatory Commission.

He is an adjunct professor at The Ohio State University Moritz College of Law, teaching a course on oil and gas law. The blog highlights news and breaking legal developments involving the crude oil and natural gas industries, alternative and renewable energy resources and the latest environmental issues. Greg serves as the general counsel of the Ohio Oil and Gas Association, and is a member of the Ohio State Bar Association, the Energy and Mineral Law Foundation, the Rocky Mountain Mineral Law Foundation, and the Marcellus Shale Coalition.

Greg received his J.D. from Harvard Law School and his B.A. summa cum laude from Washington and Lee University. He received a Fulbright Grant to study mathematics at the TH Darmstadt in West Germany in 1988-1989.
