She previously served as Senior Executive Vice President, Occidental Petroleum Corporation and President, Oxy Oil and Gas, where she was responsible for operations in the U.S., the Middle East region and Latin America. Prior to that, Ms. Hollub held a variety of leadership positions, including:

President, Oxy Oil and Gas, Americas; Executive Vice President, U.S. Operations, Oxy Oil and Gas; Executive Vice President, California Operations; and, President and General Manager of the company's Permian Basin operations. She started her career at Cities Service, which was acquired by Occidental. Ms. Hollub serves on the board of the American Petroleum Institute and Khalifa University for Science and Technology in Abu Dhabi. Ms. Hollub holds a B.S. in Mineral Engineering from the University of Alabama, and was inducted into the University of Alabama College of Engineering 2016 class of Distinguished Engineering Fellows.

Ms. Hollub, as President and Chief Executive Officer, is responsible for all operations, the financial management of the company and for creating and implementing the company's strategy. As President and Chief Operating Officer, she managed Occidental's worldwide oil and gas operations, as well as the company's chemicals and midstream operations. Ms. Hollub brings to the Board over 35 years of experience in the oil and gas industry, having previously held a variety of management and technical responsibilities on three continents. During that time, Ms. Hollub has been instrumental in efficiently and profitably growing Occidental's oil and gas business. Her extensive operational and leadership experience brings valuable perspective to the Board.
