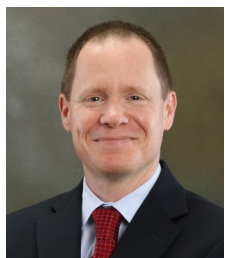

Andrew J. Black, President and CEO, Association of Oil Pipe Lines (AOPL)

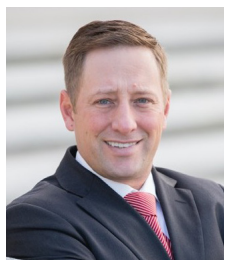
Andy Black is President and CEO of the Association of Oil Pipe Lines (AOPL), a trade association in Washington, D.C., whose membership is owners and operators of energy liquids pipelines. Liquids pipelines transport the crude oil, refined products and natural gas liquids that American consumers and workers use every day to lead their lives and fuel their jobs. AOPL promotes the safe, reliable, and efficient transportation of energy liquids by pipelines, educates the public about the vital role oil pipelines serve in the daily lives of Americans, and advocates for the interests of its members.

He leads outreach to Congress, the U.S. Department of Transportation, the Federal Energy Regulatory Commission (FERC), other government agencies, trade associations, and key stakeholder groups. Andy has testified before Congressional committees and State Legislatures on behalf of AOPL and its members, and discusses pipeline issues regularly with members of the media. He participates in industry discussions about performance improvement, manages the talented AOPL staff, and reports to the AOPL Board of Directors.

Andy previously served as Director of Federal Government Relations for the El Paso Corporation, a natural gas pipeline, producer, and LNG terminal operator. Prior to that, he was Director of the Office of External Affairs for the Federal Energy Regulatory Commission (FERC). He spent a combined thirteen years on Capitol Hill as a staff member of the House Committee on Energy and Commerce and for Congressman Joe Barton. He also spent time directing an association of government relations firms in state and national capitols.

Andy has earned the Certified Association Executive (CAE) credential from the American Society of Association Executives (ASAE), and completed the Institute of Organization Management (IOM) program of the U.S. Chamber of Commerce Foundation.

Mr. Black has a B.S. in Economics from Texas Christian University and an M.B.A. from the University of Maryland. Raised in Texas, he lives in Brambleton, Virginia, with his wife and elementary school age daughter and son.



Gifford Briggs, President, LOGA

Gifford Briggs joined LOGA in 2007 working closely with the Louisiana Legislature. After nearly a decade serving as LOGA's Vice-President, Gifford was named President in 2018.

Briggs first joined LOGA (formerly LIOGA) in 1994 while attending college at LSU. He served as the Membership Coordinator and helped organize many firsts for LOGA, including the first annual meeting, Gulf Coast Prospect & Shale Expo, and board meetings. He later moved to Atlanta to pursue a career in restaurant management. He returned to LOGA in 2007.

He is married to Jackie Wright, and the couple currently resides in Lafayette with their sons, Gifford Ashley Briggs, Jr and Maxwell Wright Briggs. and their daughter, Chloe Lane Briggs.

The Honorable Jim Gerlach (R-PA), President & CEO, BIPAC

Former U.S. Congressman Jim Gerlach (R-PA) serves as the president and chief executive officer of the Business-Industry Political Action Committee (BIPAC).

Before joining BIPAC, Rep. Gerlach had an extensive career in public service and the private sector serving Pennsylvania's Sixth Congressional District for 12 years where he had most recently served on the House Ways and Means Committee and its Subcommittees on Health and Select Revenue. In the 113th Congress, he was also the lead Republican on the Ways and Means Manufacturing Working Group. During his six terms in the House, from 2003-2015, Rep. Gerlach also served on the Transportation and Infrastructure

Committee, Financial Services Committee, and the Small Business Committee.

National publications, including *National Journal* and *Roll Call*, have recognized Rep. Gerlach's strong record as an independent voice. He is no stranger to difficult campaigns. The 6th District was ranked as the most competitive district in the nation between 2002 and 2008, according to a University of Minnesota survey.

Prior to his tenure with the U.S. Congress, Rep. Gerlach also served four years in the Pennsylvania House of Representatives and eight years in the Pennsylvania Senate. This public service was preceded by 10 years of private law practice in the Commonwealth.

Throughout his career, Jim has always stood for free enterprise. Gerlach was repeatedly named a "Guardian of Small Business" while serving the citizens of Pennsylvania as a state legislator and a Member of the U.S. Congress. While in Congress, he received perfect scores from BIPAC's Outline for Prosperity, received the U.S. Chamber of Commerce Spirit of Enterprise award, and gained support from the National Federation of Independent Business (NFIB).

Active in his community, Gerlach served as a member of the Board of Directors of the Brandywine Health Foundation, as well as a member of the Board of Directors of MECA (Mission for Educating Children with Autism), the Board of Trustees of Dickinson College, the Chester County Agricultural Development Council, the West Brandywine Township Zoning Hearing Board, and the Board of Directors of the Brandywine Hospital.

The Honorable John N. Kennedy (R-LA) *invited*

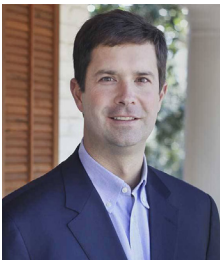
John Kennedy was elected to the U.S. Senate in 2016. He has built a distinguished career as a conservative champion for the people of Louisiana and a dedicated watchdog of taxpayer money.

Kennedy serves on the Appropriations, Banking, Housing & Urban Affairs, Budget, Judiciary and Small Business & Entrepreneurship committees in the U.S. Senate.

Prior to his election to the Senate, Kennedy was state treasurer of Louisiana for five terms. As treasurer, he oversaw the state's multi-billion-dollar investment portfolios. He also oversaw local and state bond issues and returned millions of dollars in unclaimed property each year. Prior to his position as Treasurer, Mr. Kennedy served as Secretary of the Department of Revenue, Special Counsel to Governor Roemer and Secretary of Governor Roemer's Cabinet. He was also an attorney and partner in the Baton Rouge and New Orleans law firm of Chaffe McCall.

Mr. Kennedy graduated magna cum laude in political science, philosophy and economics from Vanderbilt, was president of his senior class, and elected to Phi Beta Kappa. He received his law degree from the University of Virginia and his B.C.L. degree from Oxford University in England where he was a First Class Honors graduate.

Mr. Kennedy has been an adjunct professor at LSU Law School and a volunteer substitute teacher for public schools. He resides in Madisonville, Louisiana, with his wife Becky and their son, Preston. They are founding members of the North Cross United Methodist Church.

The Honorable Bob McEwen (R-OH)

"His clear and humorous speaking style will leave you with answers to questions you have always had but didn't know who to ask" is a quote often heard about Bob McEwen. The former Ohio Congressman uncovers the part that God and Free Enterprise have played in making America the envy of the world.

Mr. McEwen was a Presidential representative in Moscow during the Gorbachev coup, escorted the world's first non-communist Prime Minister of a Communist country into the Polish Chancellery in 1989, participated in the formation of democratic governments in Soviet satellite countries and witnessed the vote in the Kremlin that eliminated the Soviet Union. Together with three other Members of Congress he formed the "Balkan Gathering" that brings together parliamentarians each year in that troubled region of the world for the purpose of reconciliation.

McEwen was chosen by his colleagues to be a member of the coveted Intelligence Committee and also the elite Rules Committee that oversees all legislation in the U.S. House of Representatives. He also served as a member of the U.S. delegation to the European Parliament for 10 years. Currently he heads the Washington based Council for National Policy.

- the state's Master Plan for Public Postsecondary Education;

Under his leadership, financial support for public postsecondary education nearly tripled and Louisiana's colleges and universities became more engaged in addressing Louisiana's economic and social challenges.

Savoie has held numerous state, regional, and national positions. Governors M. J. "Mike" Foster, Edwin Edwards, Kathleen Blanco and Bobby Jindal all tapped him for higher education committees and commissions in their administrations. Savoie was a cabinet member in three governors' administrations – Foster's, Blanco's and Bobby Jindal's. Most recently he served on Governor John Bel Edwards Higher Education Transition Team.

The Oil and Gas Conservation Division regulates oil and gas drilling and production operations in Oklahoma to conserve oil and gas resources and protect the environment.

Before moving to Oklahoma, Lori served as Director of the Oil Conservation Division of the New Mexico Energy, Minerals and Natural Resources Department, and as Chairman of the New Mexico Oil Conservation Commission. She has recently been named to the Oklahoma EDGE Fund Advisory Committee, which assists the EDGE Policy Board in evaluating grant proposals for development and commercialization of applied research. Lori holds a B.A. in anthropology from Wellesley College, a B.S. in geology from the University of Texas, and a law degree from Harvard University.
